- 1) The base price and GST shall be shown separately
- 2) Copy of current year Trade License, PAN card, GST registration certificate shall be accompanied with the technical bid documents. [Non Statutory Documents]
- 3) The vendor shall provide Company details as per Annexure-II.
- 7) The Almirah shall carry minimum 3(three) years on site warranty from the date of supply.
- 8) The successful tenderer shall supply the Almirah within 07 (seven) days from the date of issuance of the supply.
- 9) The University authority reserves the right to accept or reject any/all quotations.
- 10) The quotation should be valid up to 31.10.2025.
- 11) The brochure /catalogue of the Steel Almirah shall accompany with the technical bid documents (Non Statutory documents).
- 12) Selection of the agency will be made on the basis of both technical and financial bids. The technical bid and the financial bid shall be sealed by the bidder in separate cover duly superscribed and both the sealed covers are to be put in a bigger cover which should also be sealed and duly superscribed. The technical bids will be opened at the first instance and evaluated. Subsequently, financial bids of only the technically accepted offers will be opened for furnishing value and ranking before finalization and issuance of supply only. After evaluation the lowest rate (L₁) financial bid from among the technically qualified bidders will be accepted.

Doors of almirah must be made of 1mm 20 gauge thick CRCA sheet providing 6 lever good quality locks, body of the almirah must be made of 1mm 20 gauge thick CRCA sheet. All steel parts shall be pretreated for nine stage anti corrosion treatment followed by powder coated of thicknees 50-60 microns complete
